The move is intended to help reduce pressure on health services handling increased volumes of patients who require online and in-practice support, plus onboarding new staff and suppliers. Yoti protects individuals and organisations from the threat of fraud attacks with verified details and a secure, privacy-preserving platform that helps people share their details in seconds.

Yoti verifies government-approved ID documents from over 185 countries, making it a global solution to onboarding staff, patients and suppliers. The highest security standards are used to verify people with a combination of world-leading technology and expert security personnel.

Yoti is architected in a way that means all data is securely encrypted and customer information cannot be sold to third parties for marketing or any other purposes. Yoti puts the individuals in control to consent to all data they share.

Robin Tombs, Yoti CEO said: "We want to do whatever we can to help individuals and organisations affected by COVID-19. Our technology and team are available to support."
