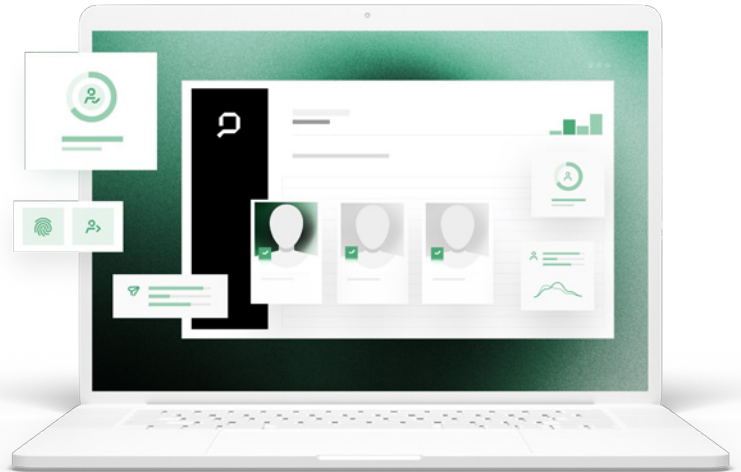
Solution
